Delray whistleblower settles lawsuit

Win is second for wastewater inspector

DELRAY BEACH - About two years into her job as a wastewater inspector, Christine Ferrigan said she had realized just how contaminated the water was in Delray Beach.

After being repeatedly ignored by her supervisors, she went to the state, she said. Then, in January 2022, her position was abruptly eliminated.

This month, the city reached a settlement to pay \$818,500 to resolve Ferrigan's whistleblower lawsuit in which she claimed to have been fired for her reports. The city commission approved

the settlement at a recent meeting.

Shockingly, it was the second time in less than 10 years that Ferrigan has picked up a sizable settlement from a city after alleging she was fired for bringing water treatment problems to the state's attention when her managers were unresponsive. In 2014, Ferrigan received \$322,500 in a settlement against the neighboring city of Boca Raton after a similar whistleblower lawsuit stemming from reported drinking-water

safety violations.

"People shouldn't be silenced not to speak because they fear for their job or retaliation," Ferrigan said. "There should be a process in place that allows them to speak and somebody objectively looking into the issues and determining, before it ever gets this far."

Delray Beach City Manager Terrence Moore, named in the suit, did not

At \$52 million, it's the most expensive single-family home listing in Boca Raton.

Earth," Detention Kingdom eliminated the common penal practice of warehousing inmates for endless days of boredom in their cells. Instead, inmates (referred to as "con members") spend their days in the brightly painted, wellmanicured prison grounds, where they mill about in the blazing sun, standing in long lines to go on a variety of short rides, or to step inside for fleeting moments in mercifully air-conditioned
